Notes regarding the operating manual

Symbols



Warning of electrical voltage

This symbol indicates dangers to the life and health of persons due to electrical voltage.



Warning

This signal word indicates a hazard with an average risk level which, if not avoided, can result in serious injury or death.



Caution

This signal word indicates a hazard with a low risk level which, if not avoided, can result in minor or moderate injury.

Notice

Safety

Read this manual carefully before starting or using the device. Always store the manual in the immediate vicinity of the device or its site of use!



Warning

This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.

- Do not use the device in potentially explosive rooms.

- Never immerse the entire device in a liquid. Only the measuring probe is intended to be immersed.

- Do not open the device with a tool.
- Only use the device if sufficient safety precautions were taken at the surveyed location (e.g. when performing measurements along public roads, on building sites etc.).
 Otherwise do not use the device.
- Observe the storage and operating conditions as given in the Technical data chapter.



Intended use

Only use the device BW05 for determining the water content of type DOT3, DOT4 and DOT5.1 brake fluids.

To use the device for its intended use, only use accessories and spare parts which have been approved by Trotec.

Improper use

Do not use the device in potentially explosive atmospheres or for measurements at live parts.

Trotec accepts no liability for damages resulting from improper use. In such a case, any warranty claims will be voided.

Any unauthorised modifications, alterations or structural changes to the device are forbidden.

Personnel qualifications

People who use this device must:

 have read and understood the operating manual, especially the Safety chapter.

Be careful when handling acids such as brake fluid!

If you are unsure whether or not a liquid has a corrosive effect, wear suitable protective equipment consisting of eye protection, protective clothing, protective gloves and safety boots in any case.

Information about the device


Device description

The device BW05 can be used to determine the water content of type DOT3, DOT4 and DOT5.1 brake fluid.

The water content is an indicator of the condition of the brake fluid and thus of the braking system.

The brake fluid condition can be quickly read and interpreted using the 3-colour LED.

Transport and storage

Notice

If you store or transport the device improperly, the device may be damaged.

Note the information regarding transport and storage of the device.

Transport

Make sure that the protective cap is attached to the measuring probe.

Storage

When the device is not being used, observe the following storage conditions:

- dry and protected from frost and heat
- protected from dust and direct sunlight
- The storage temperature is the same as the range given in the Technical data chapter.
- Remove the batteries from the device.

Operation


Inserting the batteries

Insert the supplied batteries into the device before first use.

Notice

Make sure that the surface of the device is dry and the device is switched off.

- 1. Open the battery compartment.
- 2. Insert the batteries (3 x LR44 button cells) into the battery compartment with correct polarity.




3. Reattach the cover to the battery compartment.

Removing the protective cap

The measuring electrodes are protected from external influences by means of a protective cap.

1. Prior to every measurement pull the protective cap off the measuring electrodes.

Make sure that both measuring electrodes are free from dirt and residual fluid.



2. After every measurement put the protective cap back on the measuring electrodes.



Setting the measuring mode

The measuring device can be used to measure the water content of 3 different types of brake fluids.

Туре	Measuring mode LED	
DOT3	red	
DOT4	green	
D0T5.1	orange	

- 1. Press the *TEST* button (1) to switch the device on.
 - ⇒ The measuring mode LED (5) indicates the currently selected measuring mode.
- 2. Press the TEST button (1) for approx. 5 s.
 - ⇒ The indicator LED (6) briefly lights up in all 3 colours.
 - ⇒ The measuring mode LED (5) flashes in the colour of the currently selected measuring mode.
- 3. Press the *TEST* button (1) to switch between the measuring modes.
- 4. Wait a moment until the measuring mode LED (5) stops flashing.
 - ⇒ The measuring mode LED (5) indicates the selected measuring mode.

Measuring

The indicator LED (6) is able to show 3 different brake fluid conditions:

Indicator LED	Water content	Brake fluid condition
green	< 1.5 %	Brake fluid is in good condition.
yellow	1.5 % to 3 %	Brake fluid is still OK but should be checked regularly.
red	> 3 %	Brake fluid must be exchanged immediately; risk of a braking system failure.

Proceed as follows to check the water content of the brake fluid:

- 1. Press the TEST button (1) to switch the device on.
- 2. Check whether the measuring mode set corresponds to the type of brake fluid to be tested.
- Immerse the measuring probe in the brake fluid. Make sure that the measuring electrodes are completely surrounded by brake fluid and that the measuring probe does not touch the walls of the fluid reservoir.
- 4. Wait for approx. 3 s.
 - ⇒ The indicator LED (6) shows the condition of the brake fluid.

Switching the device off

The device switches off automatically if no button was pressed for approx. 20 s.

- 1. Briefly press the *TEST* button (1) twice to switch the device off.
 - ⇒ The measuring mode LED (5) goes out.
- 2. Clean the measuring probe and electrodes with a cloth and wipe them dry.
- 3. Put the protective cap (4) on the measuring electrodes.

Maintenance and repair

Battery change

A battery change is required when the indicator LED (6) lights up red three times and the device turns off, or when the device can no longer be switched on (see chapter Inserting the batteries).

Cleaning

Clean the device with a soft, damp and lint-free cloth. Ensure that no moisture enters the housing. Do not use any sprays, solvents, alcohol-based cleaning agents or abrasive cleaners, but only clean water to moisten the cloth.

Repair

Do not modify the device or install any spare parts. For repairs or device testing, contact the manufacturer.

Disposal
